renew the instructions. Considerable effort was expended contacting individuals and banks to the extent that other membership renewals were neglected.

We are now in a handover phase to a new membership secretary and work continues during this period to rationalise membership and persuade lapsed members to "rejoin".

It has been a quiet year for BRISC as we have awaited developments arising from SBIF and the NBN. The NBN's Atlas of Living Scotland is potentially a very big change in the way that we will interact with biological data online and also perhaps open it up to new audiences. It will be launched in 2016. The new style of Recorder News has been produced and it seems the A5 format has worked well and has saved a great deal on postage without compromising on quality. Well done to our editor Sarah Eno.

AGM

The Conference and AGM were held at the Loch Lomond and Trossachs National Park HQ. Almost 30 people attended and the speakers were excellent, with lots of good questions and discussion. The field trips to the Rowardennan Field Centre and the Queen Elizabeth Forest Park were blessed with good weather. Many thanks to Gwenda Diack of the Park for helping organise the day. *

BRISC Committee

The committee has met three times in the last year and we welcome back our Secretary Louisa Maddison from her maternity leave. We did miss her. National data issues have often been the main topic of conversation at these meetings and this has led to a joint meeting between the NBN, SBIF and BRISC to agree on a memorandum of understanding defining how our organisations will work together and what exactly we are seeking to achieve with respect to biological recording and data management in Scotland.

The letter to the deputy Environment Minister (mentioned in the last annual report) is in draft and will be sent out after the Conference and it will report back on the outcome of the conference as well as the responses we received from both National Parks regarding their policies and actions to support volunteer biological recording and ensure good data management.

Duncan Davidson is standing down at the AGM as the Treasurer and Membership Secretary. Andy Wakelin has kindly offered to take over the role of Membership Secretary. That leaves us requiring a Treasurer, Duncan is staying on until we can find a new one and he will arrange a formal handover of the accounts. Many thanks to

Duncan for all his work in sorting out the accounts, managing them and making sure our finances are in good health.

Scottish Biodiversity Information Forum (SBIF)

SBIF is moving, but slowly and some of this is due to the old story of a lack of genuine partner buy-in to the project. I am ever hopeful that progress will be made in the coming year on this matter and we can start delivering on some of the actions outlined in the inaugural BRISC conference of 1975. The finalisation of the National Data Flow Pathway is a good start, this was launched on the 16th of April at the first SBIF Conference. The attendance was large, 55 in total (and the attendees young - under 40...), and enthusiasm level high, let's hope this is a taste of things to come. There was also an excellent Citizen Science event on the 5th of May run by SNH, again lots of enthusiasm and lots of great schemes gathering biological data. It is easy to get cynical about national data issues but days like the two aforementioned ones do help to dispel the gloom somewhat.

Bursaries

There were 67 of applications to the 7 bursary places offered this year. Further work is required to secure more funding for this. In the next three years the Glasgow Natural History Society has committed to providing 4 bursaries annually, BRISC has committed to 2 annually for three years and in the coming year an anonymous donor has provided another one.

NFBR.

I have not managed to attend any NFBR meetings this year due to pressure of work. They are continuing to develop and seeking funding to get some posts in place to speed this up. http://www.nfbr.org.uk

Membership/ Finances.

As with previous years our membership is fairly static, but we are trying to get new members by offering a student membership of $\pounds 5$. This will be put this year's AGM for a vote. Our finances are again fairly static with our income and expenditure for core tasks roughly in balance but our overall capital declining due to the Bursaries and SBIF contribution.

Other news

As you may have remembered from last years report (and the one before that), I said I was standing down and I will be at this AGM. So please if you would like to be the next Chairman or Chairwoman of BRISC please do come and speak to me at the conference. If no-one is willing to stand for this post at the Conference, then the committee will seek to find a new Chairman/ woman for BRISC.

I have really enjoyed my time as the BRISC Chairman and found it very rewarding as I strongly believe in what BRISC seeks to do.
